



Uber Accident Claims in Pennsylvania: What You Need to Know

In 2016, Pennsylvania passed its [Rideshare Act](#) that helps ensure you get compensated fairly if you are injured in a crash involving a rideshare service.



Insurance Requirements Are Different For Each

- If the car is not engaged with a prearranged ride: \$50,000/\$100,000 for death and bodily injury, \$25,000 property damage. Medical Benefits \$25,000 for pedestrians, \$5,000 for drivers.
- While engaged with a prearranged ride: \$500,000 for death, bodily injury and property damage. Medical Benefits \$25,000 for passengers and pedestrians, \$5,000 for the driver.



Important Provision

Rideshare companies and their insurance companies must provide ride information to involved parties including precise times of log on/off of network for 12 hours before and after an accident.

Notable Vehicle Standards

- Vehicle must be for less than 10 persons
- Have at least 4 doors
- Is a coupe, sedan, or light-duty vehicle
- Is not a salvage vehicle
- Is not more than 10 years old

Notable Driver Standards

- Must possess valid DL
- At least 21 years old
- Has not had >3 moving violations in past 3 years
- Has not had limo/taxi certificate suspended or revoked within 5 years
- Pass criminal background test

Is Uber Held Responsible If My Driver Is Negligent?

Drivers are known as independent contractors therefore uber does not hold liability over a how a contractor drivers. However, Uber has settled out of court over accident victim's claims.



Does Uber Provide Insurance For Their Drivers?

In Pennsylvania, Uber is required to provide liability and personal injury insurance for drivers while they are logged in and taking riders.
